

Levelized Billing

Want to smooth out most of the fluctuation in the amount you pay for your monthly electric bill and not worry about a settle-up month?

If so, sign up for **Levelized Billing**. You qualify if you have been a CEC residential customer for at least 12 months and have a good payment history.

Levelized Billing calculates an average cost based on a 12-month moving average of electric usage. The average simply recalculates each month, helping guard against unexpectedly high bills due to colder winter temperatures or hotter summer temperatures.

Levelized Billing does not reduce your overall energy expense; it simply helps guard against unexpectedly high bills.

Levelized Billing payments are determined for a particular residence and are not transferable. When service is terminated at one location, the **Levelized Billing** account is closed, and a final bill is rendered.

If you're not completely satisfied, you may stop **Levelized Billing** at any time.
